Under Bee's leadership, Texas Impact has moved from fewer than 1,000 members to more than 20,000 members and earned recognition as a national leader in interfaith education and community leadership development.



Bee spent eight years as a senior fiscal policy analyst for former Texas Comptroller of Public Accounts, John Sharp. Bee was responsible for the Comptroller's attention to public policy issues related to health and human services. She was the chief architect of Family Pathfinders, a unique program linking Texas congregations and civic organizations with families on public assistance.

She holds a B.A. in Drama from the University of Texas in Austin, and a M.A. of Public Affairs from the Lyndon Baines Johnson School of Public Affairs at the University of Texas.



Mike Seifert, ACLU of Texas



Michael Seifert has lived in Texas border communities since 1989, when he came to the Rio Grande Valley as a Roman Catholic priest. He met the ACLU when the organization offered to advocate for the US citizen members of his parish, who, have been born by midwives, were being denied passports by the State Department (a rule created to address supposed fraud by some of the midwives). Along the border, a citizen without a passport cannot cross back and forth into Mexico, meaning that there can be no visits to a physician, or to a grandmother, or to the funeral of a loved one.

After 24 years of service as a priest, Seifert married in 2009 and took up the responsibilities as the Network Weaver for the Rio Grande Valley Equal Voice Network. The Network shaped collective impact efforts on behalf of more than sixty community-based organizations, and effectively brought the voice of the poorest of Texans to the tables of decision makers. In 2017, Seifert accepted the position of Border Advocacy Strategist for the ACLU of Texas, working out of the Brownsville office. The position allows him to continue to advocate for border communities at a time when national and state politics are willing to deny those residents basic rights enjoyed by the rest of Americans.

He and his wife, Dr. Marsha Griffin, live in a home just a half a mile from the border. In the morning, they enjoy the sounds of the birds that migrate freely, north and south, without passports, high above the border wall.

Ilka Vega, Hope Border Institute

Ilka Vega was born in El Paso, Texas and raised in Cd. Juarez, Mexico. She was raised in the Roman Catholic tradition by her mom and grandmother. In 2016, Ilka conducted a research with the grassroots network of Texas Impact to better learn about water issues affecting the Texas-Mexico border and the activism around it.

She is very passionate about social and environmental justice and completed an internship in the Texas 16th Congressional District office where she specialized in immigration related congressional inquiries to the Department of State and the Department of Homeland Security. She



currently serves as a representative of the South-central jurisdiction for the Racial Justice Charter Support Team for the United Methodist Women and administrative and community engagement specialist for Hope Border Institute.

Thomas Ratliff, The Ratliff Company

Thomas Ratliff began his work as a legislative consultant as Director of External Affairs for AT&T Wireless Services. In 1998, he opened Ratliff Company and began consulting for many top industries in Texas. Clients have included Fortune 500 companies and trade associations in telecommunications, Internet and software technology, electric utility, insurance, nursing, and other industries such as economic and business development.

In 2010, he was elected to the State Board of Education and was re-elected in 2012 to a term that ends in 2016. In 2013, he worked with Michael Morton to pass the "The Michael Morton Act" which was the first major criminal justice reform in Texas in many years.

Doug Lewin, Energy Foundation

Doug Lewin is founder and principal of Stoic Energy, Inc.; Texas Director for the Energy Foundation, Adviser to the Cynthia and George Mitchell Foundation's Energy Program; and Director of Texas A&M Energy Systems Lab's Texas Energy Summit.

Over the previous two years, Doug Lewin led CLEAResult's regulatory and market development efforts across North America. CLEAResult is a leading energy efficiency program implementer for over 250 utilities in 40 states and provinces. Prior to joining CLEAResult, Lewin was the



founding Executive Director of the South-Central Partnership for Energy Efficiency as a Resource (SPEER). SPEER was recognized by the US Department of Energy as the regional energy efficiency organization (REEO) for Texas and Oklahoma, working with a network of REEOs throughout the US to advance energy efficiency.

Lewin worked at the Texas Legislature for five years, primarily on clean energy issues for three different elected officials in the House and Senate. There, he established a successful bipartisan energy policy working group which helped advance clean energy policies. Lewin earned his Bachelor's and Master's degrees from the University of Texas at Austin.

Representative Mary Gonzales



In November 2012, Mary E. González was elected State Representative for House District 75—an area that includes east El Paso County, the fastest growing parts of the city of El Paso and the towns of San Elizario, Socorro, Clint, Fabens, and Tornillo. Mary was raised in Clint, Texas and graduated from Clint High School. She is currently serving her fourth term at the Texas House of Representatives.

Mary serves on the Appropriations Committee, the Public Education Committee, and is Vice Chair of the Local & Consent Calendars Committee in the Texas House. Throughout her time as a State Representative, she has

authored numerous bills to improve public schools, increase economic development, and support agriculture in House District 75 and throughout the state. She is currently serving her second term as Vice Chair for the Mexican American Legislative Caucus, a second term as Secretary of the House Border Caucus, and the Chair of the new Texas House LGBTQ Caucus.

Mary received her Bachelor's Degree from the University of Texas at Austin and her Master's Degree from St. Edward's University. Currently, she is pursuing her Doctoral degree in Curriculum and Instruction- Cultural Studies in Education at UT-Austin.

Mary was named "Freshman of the Year" by the Mexican American Legislative Caucus, a "Champion of Equality" by Equality Texas two sessions in a row, and the 2015 "Advocate of the Year" by the same organization. In 2015, she was the youngest inductee into the El Paso Women's Hall of Fame. Most recently, Rep. Mary González was awarded the "Champion for Children" title by the Equity Center, a Texas-based nonprofit organization that strives to create a more equitable public-school finance system.

Representative Shawn Thierry

State Representative Shawn Thierry is a member of the Texas House of Representatives, serving House District 146, which includes diverse communities in Southeast and Southwest greater Houston. Ms. Thierry is a proud product of the public education system. She attended Westbury High School, located in her district. In 1991, she obtained her Bachelor of Arts degree from Howard University in Washington, D.C. She went on to receive a Juris Doctorate Degree from Thurgood Marshall School of Law at Texas Southern University.



Ms. Thierry has practiced law for more than twenty-two years and founded her own civil and commercial law firm, the Law Offices of Shawn Thierry. Presently, she is a principal of the Hardwick Law Firm, LLC, where she practices in the areas of real estate development, municipal law, and public finance.

In her initial term in the Texas Legislature, Rep. Thierry successfully authored 48 pieces of legislation. She is recognized statewide and nationally for passing legislation to reduce the alarming maternal mortality and morbidity rates for Texas women. Representative Thierry was also named the "2017 Freshman Legislator of the Year" by the Texas Legislative Black Caucus.

Ms. Thierry is a congregant of Wheeler Avenue Baptist Church and resides in the Northfield community of her District with her five-year-old daughter, Klaire Bijou. She cites her life creed from the words of Erma Bombeck: "When I stand before God at the end of my life, I would hope that I would not have a single bit of talent left and I could say, 'I used everything that you gave me."

Patrick Bresette, Children's Defense Fund



A leader in policy and advocacy for more than 23 years, frequent public speaker and national advisor, Patrick Bresette brings a broad understanding of how to work with and within the public sector to create positive social change for children and families. He joined Children's Defense Fund as Texas Executive Director in 2014.

Mr. Bresette was previously the Executive Director of Public Works, where from 2004-2014 he helped to transform and build public will for the common good by engaging more Americans in an active pursuit of a government that works for all. He has traveled to dozens of states to train advocates, nonprofits, community leaders, public officials and organizers on how to

defend public programs and the role they play in the lives of children, families and communities. From 1991-2004, Mr. Bresette was Associate Director of the Austin-based Center for Public Policy Priorities where he was responsible for launching the Texas Kids Count Initiative and spearheading the Center's child advocacy work. He has led statewide coalitions in the development of shared legislative priorities and has testified frequently before House and Senate committees and administrative hearings on behalf of low-income Texans, especially children.

Mr. Bresette is a devoted husband, father of four, and grandfather to three young grandchildren in a vibrant bi-racial household in central Texas. He holds an MPA from the LBJ School of Public Affairs at the University of Texas at Austin and a BFA in Sculpture from the New York State College of Ceramics at Alfred University. Harriett Jane Olson, United Methodist Women

Harriett Jane Olson has served as chief executive officer of the United Methodist Women's national administrative and policymaking arm since 2007. United Methodist Women is a nearly 800,000-member organization within the United Methodist Church in the United States.

United Methodist Women members give about \$15 million a year for work with women, children and youth in the United States and around the world. UMW operates and owns the Church Center for the United Nations in New York City, a retirement home for deaconesses and missionaries in North Carolina, a publication and distribution network, and a series of mission education and leadership development events



annually. Through these events and our connections around the world, UMW staff and members are inspired, prepared, encouraged and celebrated for their direct service and advocacy for justice.

A Harvard Law School graduate, Ms. Olson practiced real estate and environmental law (1983-96) at a N.J. law firm that is now part of Day, Pitney, before working for the church full-time. From 1996-2007, Ms. Olson was senior vice-president for publishing, editor for church school publications and United Methodist Church book editor at the United Methodist Publishing House in Nashville, TN.
