# Why are you concerned about gun violence?

### Homicides

- Black men make up less than 2% of the population and are 25% of gun homicides
- Black Americans as a whole are 6 times more likely to die by gun homicide than White Americans
- Young Hispanic men are 3 times more likely to die by gun homicide.


# % Homicides Using a Gun Other Method

Nationwide rate: 4.1 gun homicides per 100,000 people





#### **Domestic Violence**

- 205 Texans killed by domestic violence in 2023
- Domestic abusers with access to a firearm are 5 times more likely than other abusers to kill their partner.









#### **Guns are killing Texas Youths**


A total of 295 Texans younger than 18 died from gunshots last year. Each of the dots below represents one of those Texans who lost their life to guns.



# "Hardening"

- Increase in security measures at vulnerable locations like schools
- Can help mitigate a crisis
- Doesn't prevent shootings

#### **Stand Your Ground**

- One study published in 2014 by a team from Johns Hopkins uncovered how efforts by the Missouri GOP to overturn that state's permit to purchase handguns law were associated with an increase in annual firearm homicides of 1.09 per 100,000, which works out to an increase of between 55 and 63 homicides per year in Missouri.
- Right-to-carry laws allow people to carry concealed weapons in public
- Several studies linked increased firearm exposure in the general population to increased gun homicides, suicides, workplace shootings, and the like.
- "Stand your ground laws" allow "defensive" firearm use when people feel threatened
- In 2017 the Journal of the American Medical Association found that Florida's stand-your-ground law implemented in 2005 has led to an increase in the state's overall monthly homicide rate by 24.4% and the homicide by firearm rate by 31.6%

### Myths


- Cities are overrun with crime

### Reality

- Rural populations have had the a largest increase in gun violence, and now surpass city rates
- Immigrants (legal and non) are less likely than Americans to commit crimes
- Mental health is a factor in mass shootings, but not in the way people think

#### Deep South has highest rate of gun deaths among major regions







# Safe Storage

#### Safe Storage and Gun Sales: HB 639 by Rep. Goodwin

SB 661 would require licensed firearm dealers to provide a firearm safety device or secure firearm storage device and certain information with the transfer of a firearm

# Raising the age to own/purchases semi-automatic-style rifles

# Raising the Age to Purchase Certain Rifles: HB 313 by Rep. Johnson; HB 306 by Rep. Lalani; HB 384 by Rep. Goodwin

These bills would raise the age to purchase certain semi-automatic-style rifles to 21 years of age. Most mass shooters are under the age of 21 and frequently use semi-automatic-style rifles. By raising the age to buy these types of rifles to 21 (which is also the legal age to purchase handguns) Texas could decrease the likelihood of mass shootings.

### **Investing in Community Violence Intervention**

#### Creation of Office of Youth & Safety: SB 661 by Sen. West

SB 661 would create the Office of Youth Health & Safety, an office dedicated to promoting trauma-responsive and culturally informed services for children engaging in delinquent conduct in a manner that supports the child's successful transition to adulthood. The office would provide much-needed resources to communities that experience higher levels of violence.

#### **Investing in CVI: HB 230 by Rep. Rosenthal**

HB 230 would create the Office of Community Violence Intervention and Prevention and dedicate resources to community violence intervention (CVI) programs. CVI programs have shown success in reducing violence across the country by relying on credible community relationships and addressing systemic issues that lead to violence such as food insecurity.

### Removal of Firearms from Prohibited Persons

#### Disposal of Firearms by Prohibited Persons: HB 857 by Rep. Moody

HB 857 requires the disposal of firearms by individuals prohibited from owning firearms, such as convicted felons, those convicted of family violence, and others. Often those forbidden from owning firearms face no legitimate process to ensure their firearms are disposed of or surrendered—HB 857 fills this gap and creates such a process.

#### Surrender of Firearms and Protective Orders: HB 234 by Rep. Johnson

HB 857 creates process to remove firearms from someone with a family protective order against them.

## **Addressing Gun Trafficking**

#### Firearm Trafficking: HB 214 by Rep. Guillen

HB 214 creates a state level offense for firearm and ammunition smuggling and terrorism. This follows federal statute and would help address straw purchasing and illegal gun trafficking.



Gun suicides and gun murders in U.S.





% of U.S. gun deaths, by type





Gun deaths per 100,000 people (age-adjusted), by type





#### Gun deaths among U.S. kids increased 50% between 2019 and 2021


Gun deaths among U.S. children and teens under 18







In 2021, the total number of **guns produced** for the U.S. market reached 474 million. The number in circulation is lower due to **attrition**, but by how many is unclear.

# The Dickey Amendment, 1996

- Stipulated that "none of the funds made available for the injury prevention and control at the Center for Disease Control and Prevention may be used to advocate or promote gun control."
- Created a chilling effect in federal research into gun violence
- Divided states by ideology and information

# The Heller Decision, 2008

- District of Columbia v. Heller, case in which the U.S.
   Supreme Court on June 26, 2008, held (5-4) that the
   Second Amendment guarantees an individual right to possess firearms independent of service in a state militia.
- Started new era of gun ownership
- Led to deregulation of firearms in some states

# The Mass Shooting Epidemic

- Reinvigorated research into gun violence
- Parkland shooting led to the clarification that the Dickey Amendment does not prevent federal research into gun violence
- In 2019 Congress resumed allocated funds to federal research into gun violence

# The Bipartisan Safer Communities Act, 2022

- Passed in reaction to the Buffalo, NY and Uvalde, TX mass shootings
- Enhance Background Checks for Buyers Under 21
- Disarm Domestic Abusers
- Crack Down on Gun Trafficking
- Funds for mental health, school safety, CVI programs, and state Red Flag laws

# The Bruen Decision, 2022

- New York Rifle & Pistol Association Inc. v. Bruen
- At issue was a permit law on the books in New York City since 1913 that allowed officials to regulate who could carry loaded guns into some public spaces
- Was a law that was instrumental to NYC decrease in gun violence
- 6–3 decision, the Supreme Court ruled that New York's law was unconstitutional and that the ability to carry a pistol in public was a constitutional right guaranteed by the Second Amendment.
