#### **Keynote Speakers**



**Cynthia Fierro Harvey** serves as bishop of the Texas Annual Conference of The United Methodist Church, having been assigned there in November of 2022. The Texas Annual Conference is composed of 304 congregations and represents a region encompassing Galveston, Houston, College Station, Beaumont Texarkana, Longview, Tyler and towns in between.

Under Bishop Harvey's leadership, the Texas Annual Conference follows a mission to equip congregations to make disciples of Jesus Christ for the transformation of the world to the glory of God and holds a vision of vibrant, growing congregations changing lives and reshaping futures for Jesus Christ. The Conference is driven by the core values of radical hospitality, passionate worship, faith-forming relationships, risk-taking mission, extravagant generosity, connectional ministry, fervent prayer and diligent study of scripture. Bishop Harvey challenges faith

communities to look beyond themselves and to keep an eye focused on the edge where God is at work. She also has a passion for young people as they lead the church into a future filled with possibilities.

She previously served as bishop of the Louisiana Annual Conference for 10 years beginning in 2012. She served on the Board of Trustees for Centenary College, the Louisiana United Methodist Foundation, and the Louisiana Interchurch Conference as part of her episcopal assignment to Louisiana. She currently serves on The Board of Directors of Houston Methodist Hospital, Wiley College Board of Trustees, Southwestern University Board of Trustees, The Board of Directors of Lydia Patterson Institute. She also serves as the President of The General Commission of Archives and History of The United Methodist Church. Previously she served as the President of the Council of Bishops 2020-2022, President-designate 2018-2020 and as the Secretary of the Council of Bishops 2014-2018.

After graduating from the University of Texas in Austin in 1980, Bishop Harvey spent 12 years in the corporate world as a regional director of marketing for The Rouse Company, a shopping center developer with properties throughout the United States. She focused on properties in Texas, Colorado, Arkansas, and Louisiana.

Harvey went on to serve as associate pastor of The Foundry United Methodist Church in Houston from 1992-1996 and as executive pastor for Memorial Drive UMC in Houston from 1996-2008. She then moved to the position of Director of Missional Excellence for the Texas Annual Conference, serving from February of 2008-May 1, 2010. Just prior to her election as a United Methodist bishop in 2012, Harvey served as Deputy General Secretary for United Methodist Committee on Relief (UMCOR). She is a graduate of Southern Methodist University, Perkins School of Theology in Dallas, where she earned a Master of Divinity and The University of Texas at Austin, where she earned her undergraduate degree in Journalism.

Bishop Cynthia Fierro Harvey was born on May 5, 1959, in Big Spring, Texas. She and her husband, Dean Alan Harvey, were married in 1981. Dean is a financial advisor and owns his own firm. Their daughter Elizabeth Grace Harvey is a design specialist and makes her home in Dallas. Dean and Cynthia love good food. They love to cook but can also give you recommendations for the best restaurants from Houston to Baton Rouge, and wherever their travels have taken them. Dean is an excellent chef while Cynthia is at his side as his sous chef (aka clean-up duty!)



**Amanda Tyler** is executive director of BJC (Baptist Joint Committee for Religious Liberty), leading the organization as it upholds the historic Baptist principle of religious liberty: defending the free exercise of religion and protecting against its establishment by government. She is the lead organizer of BJC's Christians Against Christian Nationalism campaign and co-host of BJC's Respecting Religion podcast.

Tyler is the author of *How to End Christian Nationalism*, published by Broadleaf Books on October 22, 2024. Tyler's constitutional law analysis and advocacy for faith freedom for all have been featured by major news outlets, including The New York Times, The Washington Post, CBS

News, ABC News, CNN, and MSNBC. Religion News Service named Tyler one of "2022's rising stars in religion," and she regularly preaches in churches, speaks at denominational gatherings, and leads sessions on college campuses and with community groups of all sizes.

A member of the Texas and U.S. Supreme Court Bar, Tyler has experience working in Congress, in a private legal practice, and serving as a law clerk for a federal judge. She testified before Congress in 2023 on the threats of Christian nationalism to religious liberty, and her 2022 testimony before Congress discussed the ways Christian nationalism proves cover for white supremacy. In 2018, she appeared before a U.S. Senate Committee to testify about threats to religious liberty around the world.

Originally from Austin, Texas, Tyler grew up hearing about the cherished Baptist principles of religious liberty and the separation of church and state as a member of Highland Park Baptist Church. Tyler graduated from the Edmund A. Walsh School of Foreign Service at Georgetown University with a bachelor's degree in foreign service, magna cum laude. She was hired by BJC to serve as assistant to the general counsel, working closely with Brent Walker, James Dunn, Melissa Rogers and Holly Hollman. During this time, she wrote columns for Report from the Capital, drafted statements on religious liberty issues, presented educational programs, and coordinated the broad coalition in support of the Religious Land Use and Institutionalized Persons Act.

Tyler left BJC to enroll in The University of Texas School of Law, where she received her J.D. with honors. In 2019, the school named her their "Outstanding Young Alumna." Following law school, Tyler worked in private practice and served as a law clerk for a U.S. district court judge in Dallas, Texas. She later joined the staff of U.S. Rep. Lloyd Doggett in Austin and Washington, D.C.

**Charles E. L. Brown, MD, MBA, FACOG**, is the Legislative Chair of District XI of the American College of Obstetricians and Gynecologists (ACOG). He is a 1980 graduate of the Tulane University School of Medicine. He completed his internship and residency training in obstetrics and gynecology (OB/GYN) at the University of Texas Medical Branch (UTMB) in Galveston in 1984. He followed that training with a Fellowship in Maternal-Fetal Medicine (1984-1986) in the Department of Obstetrics and Gynecology at UT Southwestern.

In 1986, Dr. Brown joined the UT Southwestern OB/GYN Department's Division of Maternal-Fetal Medicine (MFM). While at

UT Southwestern, he completed a Masters of Business Administration at the University of Texas Graduate School of Business (1991-1993). In 1994, he moved to Austin to become Medical Director of Perinatology at Seton/ Ascension Medical Center and Brackenridge Hospital. From 1999-2005 he was the Program Director for the Austin Medical Education Programs' Fellowship in Obstetrics for Family Medicine physicians. In 2004, he became the Program Director for UTMB's OB/GYN residency program in Austin. He was on the Board of Directors and served as Chief of Obstetrics at the Austin Women's Hospital, a teaching facility for the UTMB residency program. In 2016, Dr. Brown returned to UT Southwestern and served as the Associate Program Director of the MFM Fellowship Program until April of 2022. He is currently a Clinical Professor in the Department of Medical Education at Texas A&M School of Medicine.

**Giovanna Oaxaca** is Program Director for Migration Policy in the Evangelical Lutheran Church in America. Her background in politics, government and economics, and her linguistic proficiency in both English and Spanish, empower her to apply an intersectional lens to her advocacy. She works on dispelling myths surrounding migration, pushing back on restrictions that negatively impact migrating people, and building networks for community-based action. She joined the ELCA in 2020, and in addition to working for the advocacy staff, she leads advocacy for the ELCA AMMPARO strategy (Accompanying Migrant Minors with Protection, Advocacy, Representation and

Opportunities). She is a self-proclaimed foodie who enjoys not just trying new foods but re-creating them herself.



**Beaman Floyd** is a consultant and lobbyist with more than 30 years of experience in public affairs. He owns his own lobby firm, and has worked on behalf of a variety of clients, among them property and casualty insurance companies and trade associations, public education associations, parents' rights groups, local government subdivisions, higher education groups, and religious groups. His activities include legislative strategy and direct lobbying, media relations, grass roots strategy, and academic research.

Mr. Floyd has been highly involved in several major policy issues in Texas, including property and casualty insurance reform, catastrophe policy, workers' compensation reform, healthcare, public school finance, and higher education policy. He frequently represents clients in both the print and electronic media, both in Texas and nationally. He is also a regular guest lecturer to college

faculty groups, in college classrooms, policy forums, and other political and educational settings.

Mr. Floyd works with several organizations to advance the understanding of public affairs advocacy, and is currently working with international officials in emerging democracies to establish ethical lobbying practices. He is a Charter Member of the Professional Advocacy Association of Texas.

A proud Texan from El Paso, Luis received the 2013 MALDEF Award for services performed on behalf of the Latino community in pursuit of social justice, the 2011 Champion of

Equality and Justice Award from LULAC, and the 2009 Spirit of Change Award by State Rep. Joaquin Castro, among other honors. He has a Bachelor of Arts in Political Science and Speech Communications with a concentration in American Politics and Law from Trinity University in San Antonio, and his Juris Doctorate from the University Of Texas School Of Law. He is licensed to practice law in the State of Texas.



**Diana Forester** joined Texans Care for Children as the Director of Health Policy in 2022. In that role, she spearheads our work with the Texas Legislature, state agencies, and stakeholders to support health equity, improve access to health care for moms and kids, and more. Diana is frequently quoted in the media on maternal health care policy, the health insurance implications of the Public Health Emergency, children's health coverage, and more.
